

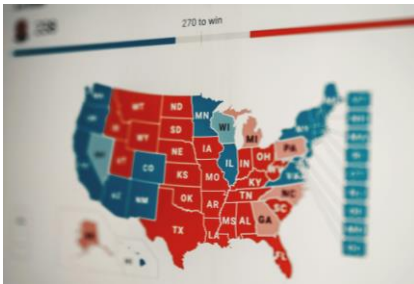

### “Self-Care for Election Season”

From September 1, there are 65 days until Election Day. September 10 is the primary day for Delaware. Every election, every ballot, every vote this year is important, just as they are every year but with an added weight. I would wager that not since the Civil War has this nation been so polarized, so divided.

Voices are exuberant or angry or silent, tempers are easily provoked, and we're all holding our breath some days. The tension is palpable on the roads and highways we drive. Continuing underneath all of this is the COVID virus still with us. It can all be spiritually

and physically draining, and so we need to be extra careful with our self-care and community care.

Maybe you've heard all of this before, from different sources, but it still bears repeating, like any spiritual practice. It also reminds us of our care for one another and that we are not alone.

1. Under times of stress and anxiety, we are more prone to accidents of all kinds and so is everyone else. Leave extra time to drive to appointments and in between events on your calendar. Be mindful of your movements on stairs and uneven surfaces. Slow down. Take deep breaths.
2. Watch only as much news as you can take. Consider reading or listening to the news instead. Subscribe to a trusted service that gives a summary description. Augment your regular news sources with news from the UCC. <https://www.ucc.org/news/>
3. As you are able, make a contribution budget and when

you have reached it, unsubscribe from the emails and texts.

4. Go to <https://www.vote411.org/> and find out all you need to know about candidates, polling places, dates and times, and to check your registration.
5. Make a plan to vote. Early voting and absentee voting are available. Go to the website above to find out what is available to you.

In 2016 we hosted what I called an Election Escape at the church. We had spaces for people to gather, eat pizza and chocolate, play games, watch election coverage, or to be in quiet and prayer. I'm planning on hosting another similar event this year on November 5 as part of our community care for this election.

Lastly, come to church however you can, whenever you can and be with people you love and who love you.

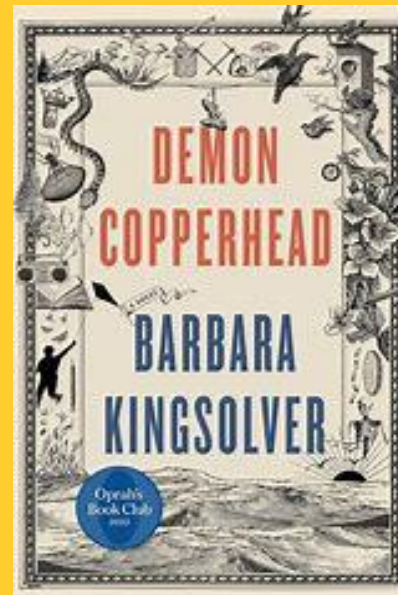
**Mind Leaps** creates educational paths for at-risk children and youth through the creative arts and 21st Century skills built on data-driven metrics.

## PCRC REPORT

The New Ark UCC congregation participated in a large survey asking questions about Pastor Cynthia's effectiveness as our pastor in a number of different areas. Many people were glad for the Zoom and Facebook opportunities to attend worship when it wasn't possible in person. Thirty-four people participated in the survey, with mostly positive responses in all of the following areas.

- **Preparation for worship**  
Everyone voted *very effective* or *effective*.
- **Leading worship**  
Everyone voted *very effective* or *effective*
- **Preaching**  
Everyone responding voted *very effective, effective, or somewhat effective*
- **Involving others in worship**  
Most were some form of *effective, 1 not effective, and 1 don't know*
- **Creativity in worship**  
All answers were *very effective or effective*
- **Involving children in worship**  
All but two answers were on the *effective* scale, *1 not effective, and 1 don't know*
- **Promoting an atmosphere of safety/inclusion**  
All were some form of *effective*

The general overall feelings were that Pastor Cynthia was very positive, including social outreach, her care for the

congregation, and her care for the community. The overall feelings of the congregation are positive.

Those who did not feel able to answer the questions said they didn't know and left their answers blank or marked them *don't know*.

In looking at the demographics of the congregation, it is seen that a small majority of the people who answered noted that they had been participating in the congregation for more than 20 years. The age range indicated that 35 people are 46 years of age or older.

The themes that were noticed by the congregation were as follows:

- **Theme 1:** Many in the congregation are very thankful to have Pastor Cynthia leading us and feel she is a good fit for our congregation. They appreciate her community and conference involvement which enlarges our image in both the community and the conference.
- **Theme 2:** Praise was given for the adaptations that were made to worshipping online and addressing the needs of the congregation during COVID.

This was an intensive study. The PCRC would like to thank all of those who took the time to share your opinions and thoughts with the committee.

**CLIMATE CHANGE —  
“Just the Facts, Ma’am,”  
Part 2**

My older brother, Ken, composed the following response to the *Arizona Courier*, addressing

an article regarding climate change. Last month's *Earthwise Tips* covered Ken's first four responses and this month's column covers responses 5-8 along with ending summary comments. I hope you find Ken's comments informative. —Ron Hartman

5) *CO<sub>2</sub> has been constant at .04 percent forever.* **False.**

Measurements of Antarctic Ice sheets show CO<sub>2</sub> concentration at 240 ± 50 ppm for 800,000 years until about 1850. Since then it increased to 420 ppm. CO<sub>2</sub> was much higher 2-3 billion years ago when plants/bacteria began reducing it to carbohydrate and O<sub>2</sub>.

6) *Mere humans cannot affect CO<sub>2</sub> level in the atmosphere.*

**False.** Until the 19<sup>th</sup> century, they didn't. Combustion was limited to cooking/heating. With the invention of the steam engine, internal combustion engine, jet engines, etc. to perform work, burning of fossil fuels increased by orders of magnitude. Also, the population exploded from one billion in 1800 to eight billion today (who exhale ~2 billion tons of CO<sub>2</sub> annually). Since 1900 nearly 1.7 trillion tons of CO<sub>2</sub> have been added to the atmosphere principally by combustion of fossil fuels. ~700 billion tons were absorbed by terrestrial and marine sinks, while ~one trillion tons remained in the atmosphere, increasing CO<sub>2</sub> from 295 ppm to 420 ppm.

7) *Volcanos spew the equivalent of decade's worth of CO<sub>2</sub> in one eruption.* **False.** The strongest eruption in the last half century, Pinatubo (1991), released ~50 million tons of CO<sub>2</sub> and Mount St. Helens (1980) released ~10 million tons. Human activity releases 40 billion tons per year. That's nearly 700 times as much CO<sub>2</sub> as the two largest eruptions produced in the last 40 years.

8) *All climate fluctuations ever observed fall within a “normal range” which is immutable.* Untestable, without a precise definition of “normal range.” Irreversible changes in the atmosphere over the earth's four billion years imply the proposition is false.

The above observations don't prove extant climate models, which predict temperature rises of 2-5 °C in the coming decades. However, the increase of CO<sub>2</sub> due to fossil fuel combustion, and the concomitant rise in global temperature over the last century, concurs with those predictions. That evidence alone indicates that it is prudent public policy to reduce and replace carbon combustion with other energy sources, as expeditiously as possible. A comprehensive, universal effort at reforestation/managing plant life to increase CO<sub>2</sub> sequestration is in order.

Just some more of the facts, folks.

## **REVIEW of OUR RISK MANAGEMENT STRATEGIES RESULTS in BYLAW AMENDMENTS**

**Votes will be taken at Special Congregational Meetings on September 8 and 22.**

Our Treasurer, Cathy Atkinson, has been reviewing the risk management checklist from our insurance company. As a result of this review, the Finance Committee is recommending two amendments to our Bylaws as strategies to reduce risks in the handling of our finances.

As you may realize, the Financial Secretary collects the donations and other payments to the church and deposits those funds into the church's bank account. The Treasurer maintains all financial records which include the income reported by the Financial Secretary and makes payments for all of the church's obligations. Our Administrative Assistant receives checks that come to the church as contributions, parking fees, rental income, and other types of income. Best practice in these situations is for the people handling funds to have a background check that includes a credit check prior to being in a position of taking on the responsibilities. The background check for those in these types of positions helps the church to maintain appropriate cash management controls that protect our financial resources.

The Finance Committee is asking the congregation to approve two amendments to the Bylaws, one to describe how those willing to serve as Treasurer or Financial Secretary will have a background check and the other amendment, describes how church employees will have a background check.

In **Article X. D. 4**, which describes how volunteers are selected, the Finance Committee is asking that this Bylaw be amended:

“Members seeking to volunteer are encouraged to submit their names to the Volunteer Enlistment Committee prior to the beginning of the meeting. However, volunteers shall be accepted until immediately prior to the lot selection.”

The language that follows is proposed to be added to this item:

“Those willing to serve as the Treasurer or Financial Secretary must have a background check that includes a credit check prior to their name being placed in the lot. The church will make arrangements for the background check and support the cost of the background check. If the background check indicates that there would be a risk to the congregation for the person to handle church funds, the individual's name will not be able to be placed into the lot.”

**Article XVII** is focused on the hiring of other staff. An additional section, D, is proposed to be added to discuss this expectation of church employees such as the Administrative Assistant:

D. If the employee will handle funds of the church, they shall have a background check that includes a credit check prior to beginning to handle church funds and at least every four years thereafter. The church will make arrangements for the background check and support the cost of the background check. If the background check indicates that there would be a risk to the congregation for the person to handle church funds, the individual will not be able to assume any responsibility for handling church funds.

This addition of a new “D” causes the original “D” to become “E.” (If you would like to see this text in the context of the full set of Bylaws, the Bylaws are available [here](#).)

Coordinating Committee has called for Special Congregational Meetings on Sunday, September 8 and Sunday, September 22, following the worship service, to vote on these amendments. As a reminder, amendments can be made to our Bylaws at two consecutive, duly-called Congregational meetings scheduled at least two weeks apart. One reason for adopting these amendments in September is to have this procedure go into effect as we select a new Financial Secretary at the October Congregational Meeting.

We have been fortunate to have had hard-working, dedicated volunteers in these positions over the last 45 years. We want to keep it that way.
